Subject: Regarding Online Divisional Judicial Seminar for all Judicial Officers posted in Durg Division (Distt. Durg, Kabirdham, Balod, Bemetara and Rajnandgaon) scheduled to be held on **17st July, 2021 (Saturday) at CSJA, Bilaspur.**

On the subject cited above, I am directed to inform you that as per the academic calendar a divisional judicial seminar for all judicial officers including Family Court Judges and Judges posted on Deputation in Durg Division (Distt. Durg, Kabirdham, Balod, Bemetara and Rajnandgaon) is scheduled to be held on **17st July, 2021**. Looking to the outbreak of Corona Virus (COVID-19), it is not possible to hold Divisional Judicial Seminar by gathering all the participants in one place. As such, CSJA is proposing to hold online divisional judicial seminar on **17st July, 2021 (Saturday) at CSJA, Bilaspur** on the following subject:

**"1. Speedy trial of civil cases: How to avoid unnecessary adjournments.
(For Rajnandgaon District)**

2. Gender Sensitization in the light of judgment of Hon'ble Supreme Court of India in Aparna Bhat and others vs. State of M.P. & another, 2021 SCC Online SC 230. (For Durg District)

**3. Tools and Techniques for expeditious disposal of Execution Proceeding(s) with special reference to Judgment dated 22/04/2021 of Hon'ble Supreme Court in the matter of Rahul S. Shah vs. Jinendra Kumar Gandhi, reported in AIR 2021 SC 2161.
(For Kabeerdham District)**

4. How to ensure basic principles of fair trial while conducting court proceedings through Video Conferencing. (For Bemetara District)

**5. Hostile witness: critical analysis of its evidence keeping in mind its trustworthiness, riders on acceptability and impact on merits of case."
(For Balod District).**

Digital Platform/link to join the online seminar will be shared with all the participants by CSJA.

It is, therefore, requested to you to inform all the Judges posted in your district including the Family Court Judges as well as the Judges posted on deputation in your district to attend the Seminar on scheduled date and time. They may be directed to report on **17st July, 2021 at 11.15 am** in the concerned Civil Court premises (where they are posted) or the home office in case of health issue or having problem to reach court premises because of containment zone, **as there will be inaugural ceremony from 11.30 a m. onwards.** They may further be directed to observe the dress code strictly as is prescribed by the High Court during the Covid-19 period.

As directed, it is further requested to kindly inform all Judges of your establishments that :

- (i) The topic mentioned above is being given to the participating Districts for preparation of papers to be presented on their behalf.
- (ii) The District Judge may select a team of three Judicial Officers across the ranks and two of them would present and read the papers in English. The presentation team may sit in video conferencing room of district headquarters/civil court complex wherever he/she is posted and ensure to wear mask and maintain social distancing. The other participants may sit in their chambers or the home office in case of health issue or having problem to reach court premises because of containment zone.
- (iii) Each District is allotted 20 minutes time for presentation and 10 minutes extra time for interaction session.
- (iv) Each District shall ensure that the soft copy of presentation is supplied to CSJA before the online seminar **latest by 12/07/2021** so that the same may be placed before Hon'ble Chairman and other Committee Members. They shall also ensure that six numbers of hard copies of the presentation are supplied to CSJA within seven days after Online Seminar.
