

Digital Platform shall be shared by CSJA to all the participants.



The eSCR Judgment search portal is a free citizen-centric service for all stakeholders, including litigants, advocates, Judges, Police officers, Law Students, Government departments, and Law researchers, and it is available 24*7. The portal is user-friendly with the free downloadable option of the Supreme Court and High Court Judgments, and it saves the cost spent by the stakeholders. The portal is accessibility compliant, and the judgments are Digitally accessible for PwD. The eSCR Judgment search portal serves as a one-stop, authenticated, unified portal for all Judgments and orders of the High Court of India. And this Judgment search portal is based on the constitutional mandate of the Right to Access Justice guaranteed under Article 21 of the Constitution

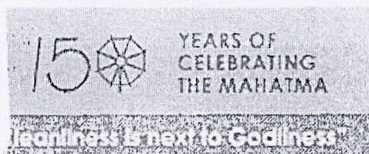

It is also humbly suggested that the online live demo may be conducted in regional languages through the master trainers available at the district level. The online demo link can be circulated

to all possible stakeholders at the District level. It is also requested that the link of the Portal can be hosted on your respective State Judicial Academy website and High Court Website for wider usage by the stakeholders.

Hence, as directed, I request your good self to have a district-level online live demo on eSCR through your State judicial academy in coordination with the Central project coordinator of your High Court, preferably before 31.03.2023

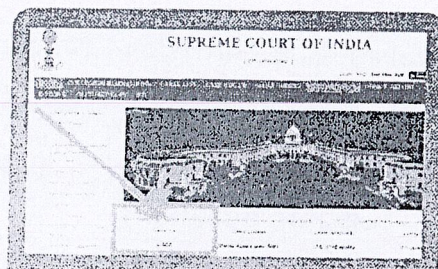

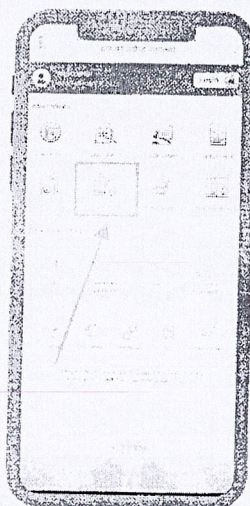
