On the subject cited above, it is to inform you that as per approved Calendar of Academy for the year 2024-25, a Divisional Judicial Seminar (Physical) for all Judicial Officers of Surguja Division (Distt. Ambikapur/Jashpur/Ramanujganj/Surajpur/Baikunthpur) including those posted on deputation (except the Judicial Officers engaged in urgent work/remand duty) will be organized on 24/11/2024 (Sunday) at Ambikapur (Venue is to be selected by the Principal District & Sessions Judge, Ambikapur) on the following topics:


1. Analysis of Law relating to Succession and Inheritance in Hindus, functioning of Customary Law in the Tribal Society and its applicability for access to Justice. (For Ambikapur District)
2. Understanding the dynamics of Human Trafficking, the role of technology and hidden chains of child trafficking. Its impact on victims and measures to combat the burning problem of Human Trafficking. (For Jashpur District)
3. The concept of Possession- Its meaning, elements, kinds and modes. Adjudication of Claims, Objections and resistance to delivery of possession to decree-holder or purchaser in execution of decree. (Section 47 Order 21 Rules 58,59 and 97 to 106 CPC) (For Ramanujganj District)
4. Provisions relating to Arrest, Remand and Bail with reference to guidelines issued by Hon'ble Supreme Court in Satender Antil vs. CBI and Siddharth vs. State of UP and Provisions relating to Disposal of property in Criminal Case. (For Surajpur District)

**5. Commission Report-Issue of Commission & Local Inspection, Procedure & Admissibility in Evidence. (For Baikunthpur District)**

It is, therefore, requested to inform all Judicial Officers posted under your jurisdiction including those posted on deputation (except the Judicial Officers engaged in urgent work/remand duty) for the above said Seminar. They may be directed to report on **24/11/2024 (Sunday) at 09.30 am** at the venue selected by the Principal District & Sessions Judge, Ambikapur. The participants shall wear decent attire i.e. sober colour Shirt, Trouser, Coat & Tie for male Officers and sober colour Saree or Suit with coat for the female Officers.

As directed, it is further requested to kindly inform all participating Judges of your establishments that :

- (i) The topic mentioned above is being given to the participating Districts for preparation of papers to be presented on their behalf.
- (ii) The Principal District and Sessions Judges, Ambikapur/ Jashpur/ Ramanujganj/ Surajpur/ Baikunthpur may select a team of three Judicial Officers across the ranks or from the rank dealing with the subject and two of them would present and read the papers in English.
- (iii) Each District is allotted 20 minutes time for presentation and 10 minutes extra time for interactive session.
- (iv) Each District shall ensure that the soft copy of presentation is supplied to CSJA before the Seminar latest by **18/11/2024** so that the same may be placed before Hon'ble Chairperson and other Committee Members. They shall also ensure that six numbers of hard copies of the presentation are supplied to CSJA within seven days after Seminar.
- (v) The minute to minute programme of the Seminar shall be prepared by the Principal District & Sessions Judge, Ambikapur and be sent to CSJA, Bilaspur prior to the date of organization of the Seminar.
