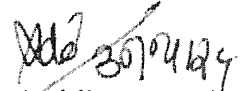

It is further requested to inform them to keep with them a copy of all the three New Criminal Laws at the time of the session.

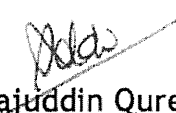
