to call the nomination of Prosecutors and Lawyers as participants from concerned Prosecution Office and the concerned District Bar Association respectively.


It is also requested to all the Principal District & Sessions Judges to nominate the Resource Person from Judicial Officers of their Own District for delivering lecture.
