On the subject cited above, it is to inform you that as per approved Calendar of Academy for the year 2025-26, a Divisional Judicial Seminar (Physical) of all Judicial Officers of Surguja Division (Distt. 1. The absent accused and the added accused- Analysing the procedural overlap between trial in absentia under Sec 356 BNSS and Sec 358 BNSS.

(For Ambikapur District)

2. Doctrine of Specific Performance of Contract-Law and Procedure with special reference to recent Apex Court's Pronouncement and explained by means of illustration of a civil suit. Limitation on the availability of Specific Performance.

(For Jashpur District)

3. The Doctrine of Competency of Court under Order 7 Rule 10 CPC. The Power To Reject A Plaint At The Threshold Under Order 7 Rule 11 CPC- A Judicial Duty Or Discretionary Power.

(For Surajpur District)

4. Provisions relating to arrest, remand and bail with reference to guidelines issued by Hon'ble Supreme Court in Satender Kumar Antil vs. CBI and Siddharth vs. State of U.P. and provisions relating to disposal of property in criminal cases.

(For Balrampur at Ramanujganj District)

5. Execution of Decree by arrest and detention in the civil prison and attachment of property. Strategies for timely and efficient enforcement.

(For Baikunthpur District)

It is, therefore, requested to inform all Judicial Officers posted under your jurisdiction including those posted in Family Courts and on deputation (except those nominated for other Workshops/Seminars/Training Programs as well as engaged in urgent work/remand duty) for the above said Seminar. They shall wear decent attire i.e. sober colour Shirt, Trouser, Coat & Tie for male officers and sober colour Saree or Suit with coat for the female officers.

- (i) The topics mentioned above are being given to the participating Districts for preparation of papers to be presented on their behalf.
- (ii) The Principal District and Sessions Judges, Ambikapur/Baikunthpur/Balrampur at Ramanujganj/Jashpur/Surajpur may select a team of three Judicial Officers across the ranks or from the rank dealing with the subject and two of them would present and read the papers in English.
- (iii) Each District is allotted 20 minutes time for presentation and 10 minutes extra time for interactive session.
- (iv) A panel of Senior Most Judges of the concerned Districts who will chair the dias during presentation and will lead interactive session as per the table below:
