On the subject cited above, it is to inform you that as per approved Calendar of Academy for the year 2024-25, a Divisional Judicial Seminar (Physical) for all Judicial Officers of Bilaspur Division (Distt. Bilaspur/Janjgir-Champa/Korba/Mungeli/Raigarh) including those posted on deputation (except the Judicial Officers engaged in urgent work/remand duty) will be organized on 08/02/2025 (Saturday) at Bilaspur (Venue is to be selected by the Principal District & Sessions Judge, Bilaspur) on the following topics:


1. Role of DNA Forensics as Circumstantial Evidence in building a strong case in absence of Direct Evidence and also to exonerate the innocent simultaneously. Admissibility and Credibility of DNA Evidence - Legal and Scientific Perspective. (For- Bilaspur District)
2. Doctrine of Specific Performance of Contract-Law and Procedure with special reference to recent Apex Court's Pronouncement and explained by means of illustration of a Civil Suit. Limitation on the availability of Specific Performance. (For- Janjgir-Champa District)
3. Electronic Evidence and its admissibility. Appreciation of Electronic Evidence-Challenges and Best Practices. (For- Korba District)
4. The scope of Sec 5 of the Limitation Act 1963 and Condonation of Delay in Civil and Criminal Proceedings with Critical Examination of the concept of "Sufficient Cause." (For- Mungeli District)

5. Supurdnama under Cr.P.C./ BNSS and under Special Acts e.g. CG Excise Act, CG Agricultural Cattle Preservation Act, Essential Commodities Act, NDPS Act, Forest Act and Wild Life Protection Act with upto date case laws of Supreme Court. (For- Raigarh District)

It is, therefore, requested to inform all Judicial Officers posted under your jurisdiction including those posted on deputation (except the Judicial Officers engaged in urgent work/remand duty) for the abovesaid Seminar. They may be directed to report on **08/02/2025 (Saturday) at 09.30 am** at the venue selected by the Principal District & Sessions Judge, Bilaspur. The participants shall wear decent attire i.e. sober colour Shirt, Trouser, Coat & Tie for male Officers and sober colour Saree or Suit with coat for the female Officers.

As directed, it is further requested to kindly inform all participating Judges of your establishments that :

- (i) The topic mentioned above is being given to the participating Districts for preparation of papers to be presented on their behalf.
- (ii) The Principal District and Sessions Judges, Bilaspur/Janjgir-Champa/Korba/Mungeli/Raigarh may select a team of three Judicial Officers across the ranks or from the rank dealing with the subject and two of them would present and read the papers in English.
- (iii) Each District is allotted 20 minutes time for presentation and 10 minutes extra time for interactive session.
- (iv) Each District shall ensure that the soft copy of presentation is supplied to CSJA before the Seminar **latest by 30/01/2025** so that the same may be placed before Hon'ble Chairperson and other Committee Members. They shall also ensure that six numbers of hard copies of the presentation are supplied to CSJA within seven days after Seminar.
- (v) The minute to minute programme of the Seminar shall be prepared by the Principal District & Sessions Judge, Bilaspur and be sent to CSJA, Bilaspur prior to the date of organization of the Seminar.


