
Sub: Regarding One Day Online Mediation Training Programme for Referral Judges.

They be further directed to report on **29th November, 2020** by 11.15 a.m. and observe the dress code prescribed by the High Court during COVID-19 period and wear mask on their faces as well as maintain social distance in case more than one person is sitting in a single room and follow the guidelines and norms issued by the Central Government and the State Government during the COVID-19 period.

A further request is made that in case of exigency any of the Judicial Officer is not present in his/her headquarter or place of posting and is present in other district within the State, he/she shall attend the Online Training Programme from nearest Civil Court building where he/she is at present with an oral information to the concerned District & Sessions Judge. All the District & Sessions Judges are requested to accommodate him/her.
