It is, therefore, requested to you to inform all the Judges posted in your district including the Family Court Judges as well as the Judges posted on deputation in your district to attend the Seminar on scheduled date and time. They may be directed to report on 12/09/2020 at 10.45 am in the concerned Civil Court premises (where they are posted), as there will be inaugural ceremony from 11.00 a m. onwards. They may further be directed to observe the dress code strictly as is prescribed by the High Court during the Covid-19 period.

As directed, it is further requested to kindly inform all Judges of your establishments that :

- (i) The topic mentioned above is being given to the participating Districts for preparation of papers to be presented on their behalf.
- (ii) The District Judge may select a team of three Judicial Officers across the ranks and two of them would present and read the papers in English. The presentation team may sit in video conferencing room of district headquarter and ensure to wear mask and maintain social distancing. The other participants may sit in their chambers.
- (iii) Each District is allotted 20 minutes time for presentation and 10 minutes extra time for interaction session.
- (iv) Each District shall ensure that the soft copy of presentation is supplied to CSJA atleast two days before the online seminar **latest by 09/09/2020** so that the same may be placed before Hon'ble Chairman and other Committee Members.
